This course provides an overview of IR theories in the field of. It is designed to (1) acquaint students with major approaches to understanding the world of international relations; (2) assess the political and historical context in which theories emerged and the interests which influenced their formulation; and (3) enable students to critically apply theoretical arguments to the reality. The course is conducted in the form of lectures. Students read selective original writings of major IR theorists, and are expected to complete all assigned readings for each week. This is a heavy load reading course on IR theory. Class participations are essential to students' final grades.
