	(三)特定重要議題分析:包括1.民主、公民權與福利國家,2.當代階級結構					
	與勞動階級,3. 新自由主義、國家與市場,4. 全球化、民族國家與全球社					
	會正義。					
	The purpose of this seminar is to examine the concrete relationships between the					
	state and society in both advanced and developing countries.					
	The seminar, first of all, investigates the historical transformation of the state and					
	society, theories of the state in the classical Marxist, Weberian and Durkheimian					
	traditions, and the emergence of the modern state.					
	The second part of the course focuses on contemporary themes of the state and					
	society relations, including state theories in the modern literature, state and the logics					
	of capital, ideology and legitimacy, and state and society in the periphery.					
	The third part of the seminar deals with certain special topics key to state and					
	society relations. They are: 1. democracy, citizenship and welfare states, 2. class					
	structure and the state, 3. neoliberalism, state and market, and 4. globalization,					
	national states and global social justice.
