修課條件：修過高等心理衡鑑與實習 (I) (II) 的臨床組研究生

上課方式：1. 講演與書報討論，輔以隨堂作業。

2. 臨床案例選讀並討論。

3. 角色演練或觀看相關之錄影帶並討論。

4. 就修課之研究生所提供之個案從心理治療學派的觀點進行個案研討與督導。

5. 就個案研討所衍生的議題進行課堂講演，輔以隨堂作業。

6. 由博班研究生助教配合授課教師課程進度帶領學生每週定時演練或討論，完成各主題之指定作業。

課程內容：1. 當代主要心理治療學派的哲學基礎及其理論回顧 (基礎篇)。

2. 專業倫理課題與個案概念化。(基礎篇)

3. 經由討論擇治療學派就其理論、治療技術及臨床應用進行深入討論。(基礎篇)

4. 行為治療簡介與綜觀，兼談本課程之授課目標。(基礎篇)

5. 行為治療學派的基本精神，行為治療的過去、現在與未來。

6 行為衡鑑。(基礎篇)

7. 逐一深入介紹各主要的行為治療技術、其基本原理、衡鑑方法、臨床應用、專業倫理課題、常見的問題及實徵研究，並配合課程性質輔以臨床案例之說明、臨床案例選讀、角色演練、或指定觀看相關之錄影帶並討論。(基礎篇)

8. 在前述基礎下，再就個案變項 (如某種心理疾患、困難個案等) 的心理處遇加以討論。(進階篇)

9. 依需要經由學生所提報的個案進行督導，逐一深入探討所運用的心理治療學派之理論、重要觀念之釐清、治療過程、治療技術的使用時機及其評估，並配合課程性質輔以臨床案例之說明、臨床案例選讀、角色演練、或指定觀看相關之錄影帶並討論。(進階篇)

10. 就該領域當前的一些重要議題進行主題探索。(加強篇)
