This course will survey the major literature in the International Relations theories under the rubric of social constructivism, including various strands of scholarship as well as its applications to the subfields of International Security, International Law, and International Political Economy. The course will also focus on the ontological, epistemological or methodological dimensions of its developments and its applications to the respective issues. The class will be conducted in seminar format. All students are required to prepare the weekly readings for class discussion. An inclass mid-term closed-books exam will be held on the 9<sup>th</sup> week. Students are also required to submit one short paper (ten thousand words in length) to critically evaluate a book/article of your choices with instructor's prior approval due on the last day of the class.
