課程目標課程概述	修習完此課程後,希望學生具備使用賽局理論來分析各種法律契約及訴訟爭議的能力。 This course has two goals. First, to introduce the formal tools of modern						
	game theory by using a number of classic legal problems ranging from tort and contract law to labor law, environmental regulations, and antitrust. Second, to show how modern game theory allows us to sharpen our intuitions and provides us with new ways of looking at familiar problems. The main textbooks for this course are "Game Theory and the Law" by Baird, Gertner and Picker (B&G&P for abbreviation) and "Games of Strategy" by Dixit and Skeath (D&S for abbreviation). This course requires mathematics only at the senior high school level such as linear algebra. Accordingly, this course welcomes students majoring in any field.
