課程結構

城市是你我生活的舞台,也是發動全球化變遷過程的引擎。到2005年,全球有一半的人口居住在都市中,而預計在2025年全球的都市人口將超過三分之二。在台灣,都市化比例已超越百分之八十。整體而言,亞洲國家,例如中國、越南、印度等,正是這一波的全球化過程中,都市化最為快速的國家。伴隨著都市化與經濟成長,亞洲城市成為全球資本流動的熱區。全球化所帶來的時空壓縮跨界生產與流動的現象,正在亞洲城市中加速進行。這些由跨界動力所催動的城市網絡間,既充滿競爭,又有不同層級的合作。然而,在亞洲國家尋求全球化路徑、創造經濟成長的耀眼表現下,隱藏著許多的社會與空間的矛盾:區域與階級的差異跨大、都市社會被政治衝突、宗教以及種族矛盾所分裂。亞洲複雜的都市化過程與全球化模式,正是都市與區域研究的重要新興課題。

本課程安排主要分成兩個部分。第一個部分介紹亞洲城市由資本與菁英所打造的全球化與空間再結構過程。這些主題包括區域經濟重組、城市的競爭與網絡化、英雄式的新都心與都市鉅型計畫的崛起、城市擴張以及鉅型都市區域內部的發展差距、由跨界的資本與菁英美學的都市意識型態所打造的新隔離主義的烏托邦、被新自由主義政策所引領的城市空間私有化趨勢、以及相對的都市貧窮問題等。我們討論的城市與區域將包括亞洲中(1)先進的經濟發展國家日本;(2)已分手揚鑣的前「東亞四小龍」經濟體;(3)新崛起的中國大陸主要城市;(4)經濟全球化中的後進國家:包括東南亞的菲律賓的馬尼拉、泰國的曼谷、馬來西亞的吉隆坡、越南河內及胡志明市,以及柬埔寨的金邊等。這幾個東南亞城市的發展將讓帶領我們檢視全球化城市中的同質化與異質化的面貌。

課程的第二個主題是全球城市中的勞工或家戶流動。城市中的移民與移工的數量的背景往往反映出一個城市的全球化位階。城市的政策與移民接近空間的權利也考驗當地社會對於新社會成員的接受度,挑戰著城市作為一個 cosmopolitan 的可能性。在前半部我們討論了以由上至下的外國資本流入所主導、以及跨界經濟整合所重塑的都市形貌之後,我們接下來將以由下而上的觀點,在 Globalization from below 架構下,討論亞洲區域內部,以及向外其他經濟區域的流動,包含全球城市中的勞工、家庭成員與家戶的流動、公民權等問題。

課程目標

- 1.使學生掌握全球化的政治、經濟與文化邏輯以及這些動力, 熟悉全球城市的主 要概念
- 2.使學生理解全球化衝擊下都市空間生產模式的改變、進一步指稱亞洲全球化城 市的特性
- 3.使學生從結構以及作用者的觀點,對東亞、中國大陸、東南亞的各主要城市所 採取的同質與異質發展路徑進行比較
- 4.定位台灣或台北在亞洲區域經濟與家戶流動中所扮演的角色
- 5.理解亞洲區域內部的國際移工與配偶的流動型態、跨界流動所帶來的公民權的 議題以及相對的國家管制等議題

課程連結

本課程將來將相銜接的課程包括「亞洲城市實習」、「全球化與日常生活」、 「亞太地區的公民社會與地方創造」等

進行方式

本課程三小時課程中,前一小時為講師授課,介紹每週課程主題的主要概念與理論發展,主要為以下列為 Introduction 部分的讀物。第二小時為同學報告所規定的讀物,也就是 Required reading 部分。多為案例介紹,以有助於比較研

究與深入探討。第三個小時為討論時間。請同學踴躍發問與討論。Recommended reading 做為同學進一步研究各主題以及寫作期末作業時的參考閱讀資料。
