比較政治專題研究

授課教師:李鳳玉、王鼎銘

一、課程介紹:

本課程有三個目的。第一個目的在於讓同學熟悉比較政治的研究方法、途徑以及重要議題。研究方法包含量化與質化法及其爭辯。研究途徑則著重在理性選擇以及制度主義途徑。重要議題則包括政治制度的成因與後果、族群政治、國家的經濟角色以及民主化等研究課題。

另一個目的在培養同學的分析能力。同學在閱讀每篇作品時,要掌握以下重點:文章的時空背景、理論與假設以及研究設計(包含變項界定、操作化定義以及統計模型等等)。同學應注意幾篇文章之間的異同與辯論,思考自己的看法,並於課堂討論時,踴躍參與。

最後的目的則是希望透過選讀博士班資格考的書單,幫助同學奠定準備資格考的基礎。

二、課程要求:

這門課程將由王鼎銘及李鳳玉老師開授。前十二週的課程由李鳳玉老師負責。 課程要求為:

- (1) 閱讀每週指定的教材,並且出席以及參與課堂討論(10%)。
- (2) 從第二週至第十二週(中間有一週放假),每週由同學報告選定的討論主題, **負責同學必須於上課前一天晚上六點以前,將報告傳給其他同學以及老師(逾** 時以零分計)。每名同學必須報告至少兩次(20%)。同學寫報告時,除了摘要 文章內容,可試著針對文章的時空背景、前提與假設、因果機制、變項界定與研 究設計等部分,加以評論。
- (3) 從第十三週起,每週須繳交當週教材的閱讀心得(35%)。
- (4) 撰寫期末報告(30%)。同學可在本課程包含的研究議題中,擇一主題撰寫研究報告。學期中,老師將安排半堂課至一堂課的時間,讓同學報告研究主題以及研究設計(5%)。
