Course Overview

This course aims to examine historical evolution of health inequalities studies and selective strategies for achieving health equity. The course consists of two parts. After reviewing the major lessons learned from the course: **Society and Health** (845 M1390), the first part presents the origin and development of public health, and research experiences in selected countries including British, Canada, and the United States. The second part begins with a review of explanations for socioeconomic inequalities in health, followed by assessing selected strategies for tackling health inequalities including tobacco control, healthy food and nutrition, healthy start, policies on employment conditions, war on poverty, healthy cities, globalization, highly performing health systems, health impact assessment, and so on.

Course Requirements

This course meets for two hours, once a week and is conducted mainly as a participatory seminar. Students are expected to read all required readings and prepare a short critique before the class. Each student is required to present and lead the discussion on one tackling strategy in the second part of the course. There will be a 10-15 page project report, due June 11, 2008. Students are to be graded according to their performance in short critique (20%), class discussion (30%), and project report (50%).
