◆ 課程概述

本課程主要是增加老師指導研究生的時間。每週安排 2 小時進行指導與諮商，惟實際課程的進行與上課地點，由授課老師自行安排。

◆ 課程目標

專題研究-婦女身體與國家政策

女人的身體在傳統上經常被界定為「私領域」的範圍，然而，屬於「公」領域的國家公權力卻經常可以影響女人身體的自處、自主與自由。這些國家政策背後的邏輯往往是「資本主義父權機制」(capitalist-patriarchy)。因此，此專題討論將探討國家政策與婦女身體的關係（尤其探討生育政策），嘗試釐清生育、婦女身體與國家之間的關係。

這門課是關於婦女身體、生育與國家的專題討論，課程目標主要訓練學生從兩個面向進行深入思考：一、從國家政策來思考其「如何透過並影響婦女身體」，來達致其政策（或者說發展）的目的；二、探討作為「身體主體」的婦女是否有協商挑戰或抵抗的空間？經由思考上述面向，加強學生在國家政策與性別議題上獨立研究的能力。

◆ 課程要求：

提交一份有關「婦女身體與國家政策」議題的描述性或分析性報告。
