

## Gender and Politics 2010 Fall

這是一門針對性別與政治的密集閱讀討論課，我們將檢視性別與政治的關係，也將不斷追問「權力是如何性別的」。在這學期的課程中，首先，我們將從引介女性主義理論中的相關議題開始，帶領同學熟習性別理論的思考方式。其次我們將探討日常生活中的互動、機構，以及認同是如何的性別。再來，我們將討論性別化的權力關係是如何展現在國家、公共領域以及政策辯論中。最後，我們將思考集體行動如何可能，以及在全球化的浪潮中，女人集體行動的可能形式及其困境。

課程要求：

1. 上課參與，佔總成績 25%。討論課的成功與否，取決於同學認真參與的程度。每一位同學都應當徹底讀完該週指定讀物，積極參與討論。同學將輪流擔任提出問題者(issue raiser)、負責於課前提出該週閱讀重要問題，並於該週結束後、下次上課前整理「課堂討論備忘錄」(discussion memo)寄給大家。
2. 每週的課前閱讀筆記(reading memo, single space, one page)，佔總成績 35%。這門課並不要求同學寫長篇研究論文，但是，同學必須撰寫課前閱讀筆記。同學可自選 8 堂課撰寫閱讀 memo。Memo 作為閱讀分析，是要分析文本的論證，並提出自己的問題，並嘗試回答；請勿寫成閱讀文章介紹。Memo 請於週四傍晚六點前(逾時不候)以電子郵件傳給大家。
3. 期末短論文，15 頁左右，佔總成績 40%。這不是一份研究報告，這是一篇分析性的短論文，探討一特定主題，這個主題應當是你在這門課程中浮現的，分析的材料是台灣可以找到的中英文學術文獻。請在第十三週時，交一頁的大綱與重要書目。最後一週上課時，進行口頭報告，我們將安排一位同學擔任評論人。請於上課前三天將您的期末報告第一稿(10 頁左右)以電子郵件傳給大家。
