課程大綱				
課程目標	<p>就歷史的觀點來看，福利國家制度是民族國家的綱領計畫，但是歐盟在歐洲整合的步驟卻逐漸影響到國家層次的社會政策。因此歐洲社會政策（European Social Policy）一詞就具有雙重意義：在西歐各福利國家的社會政策以及〈直接或間接的〉歐盟社會政策。本課程藉由分析個別福利國家的制度動態，幫助學生理解國家之間的合縱連橫關係，並領略現今歐盟在各領域的影響力，以全盤掌握國際局勢動態，培養學生的國際觀察能力。</p>			
課程概述	<p>「歐盟社會政策專題」探究主軸為歐洲社會政策的兩個層面：會員福利國家的福利制度及歐盟超國家的治理。課程首先將論述歐盟的政治機構如何形成及其具備的能力；其次，分析歐盟社會政策如何在此框架下發展，及其對各個福利國家的影響。接下來以不同的政策領域為例，闡明不同政策領域之間的進展落差：結構基金、性別平等政策、勞資關係及老年保障。課程的第三部分將討論歐洲社會政策的未來展望做為結論，並從歐盟東擴及歐盟憲法發展的觀點，看是否有所謂的歐洲社會模式。</p>
